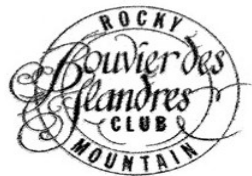

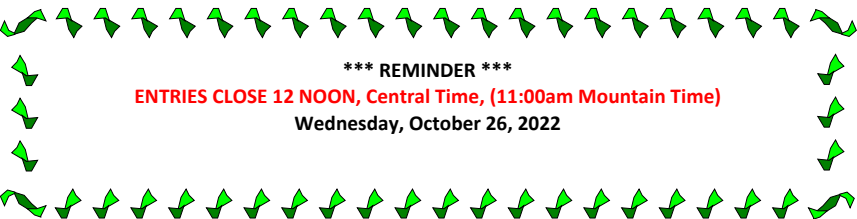

## AKC NATIONAL OWNER-HANDLED SERIES

ALL BREED SHOWS - FRIDAY, SATURDAY, SUNDAY

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

THIS COMPETITION.”**



All dogs that are owner-handled and are not exhibited in the National Owner-Handled Series by professional handlers\* meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the steward's book & the catalog. **Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers, household members and current assistants to professional handlers may not exhibit the dog in any AKC National Owner-Handled Series competition during the entire show. A current assistant is defined by anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any show during the cluster/weekend, however current assistants that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may participate in NOHS.**

Owner-Handled Best of Breed will be selected from the dogs that are competing in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes. The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed, or in Best of Winners competition.

*\*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.*

### USE OF RAMPS

A judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. AKC approval is not required.

The entire entry in a breed is to be examined in the same manner (ground, table, or ramp).

At the discretion of the judge, the following breeds may be judged on the ground or on a ramp through all levels of competition including Group and Best in Show judging: Lagotto Romagnolo, Retrievers (Nova Scotia Duck Tolling, Spaniels (American Water), Spaniels (Boykin), Spaniels (English Springer), Spaniels (Field), Spaniels (Welsh Springer), Grand Basset Griffon Vendéen, German Pinscher, Standard Schnauzers, American Staffordshire Terriers, Irish Terriers, Kerry Blue Terrier, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Finnish Spitz, Entlebucher Mountain Dog, Finnish Lapphund, Icelandic Sheepdogs, Norwegian Buhund, Polish Lowland Sheepdogs, Spanish Water Dogs, Norrbottenspets (Misc).

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on the ground, a ramp, or on a table: Whippets and Miniature Bull Terriers.

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on a ramp, or on a table: Mudi (Misc).

The following breeds must be judged on a ramp through all levels of conformation competition: Spaniels (Clumber), Spaniels (Sussex), Basset Hounds, Cirneco dell'Etna, Bulldogs, Chinese Shar-Pei, Chow Chows, and Keeshonden.

This extends to all conformation competition at AKC conformation dog shows and any AKC event where a conformation title may be earned. This policy includes Group, BIS, Junior Showmanship, the 4–6 Month Beginner Puppy Competition, the AKC National Owner-Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions.

Ramps can be used in emergency situations to judge any breed. In emergency situations where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.

For the judging of juniors the ramp may be used at the discretion of the judge for the ramp optional breeds. **Please Check [www.AKC.org](http://www.AKC.org) for updates to this list. (8/8/22)**

## JUNIOR SHOWMANSHIP COMPETITION

Novice Junior 9 & under 12 yrs • Open Junior 9 & under 12 yrs

Novice Intermediate 12 & under 15 yrs • Open Intermediate 12 & under 15 yrs

Novice Senior 15 & under 18 yrs • Open Senior 15 & under 18 yrs • Master Class

These clubs have voted to opt out of the Pilot Program for Canine Partners Participating in All Breed Junior Showmanship

**Novice Class** - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

**Open Class** - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

**Master Class** - will be for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

**NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry.**

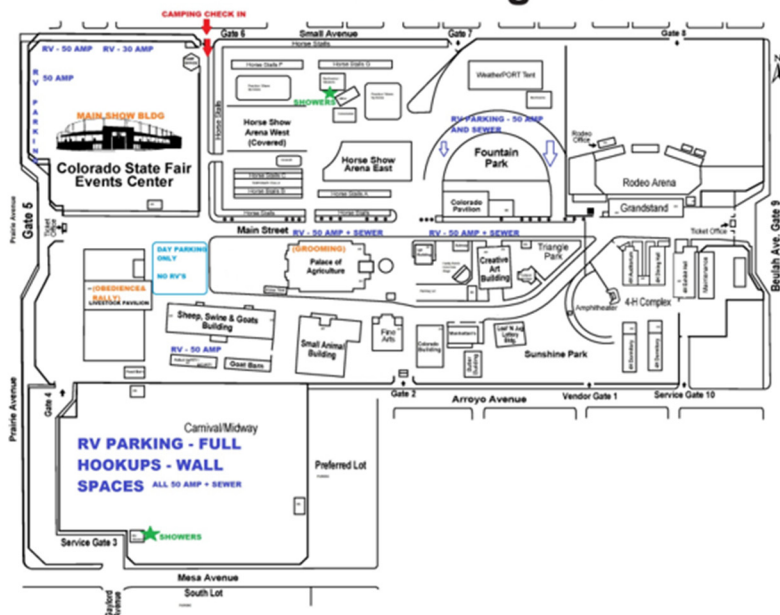

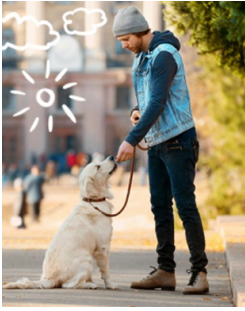
## RV/Camping Spaces:

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

## ATTENTION EXHIBITORS

**ATTENTION:** There is limited free Open Grooming in the Palace of Agriculture but there will be **NO** electricity available. **NO** generators allowed inside buildings. **NO** sharing of electricity with Reserved Grooming. **Violators will be expelled from the building.** Open Grooming spaces will be marked, please be considerate of others and take only what space you need. Stacking of crates is encouraged. Roping off or saving of space in Open Grooming will not be allowed. **FREE GROOMING WITH ELECTRICITY & COVER** is available on the north and south side of the Obedience and Rally building, the Livestock Pavilion – in the covered animal pen area directly across from the Event Center.

### PROCEDURE FOR OVERNIGHT CAMPING

All campers (including those who have prepaid) must check in at **Gate 6** on Small Avenue to obtain proper camping credentials between the hours of 8:00 am and 8:00 pm. If you arrive outside of gate hours, please park and then check in as soon as possible. Credit/debit cards will be accepted at the gate - no cash or checks will be accepted. Please make sure the Camping Permit is visible from the street. Security will be checking for proper permits each night. You will be notified by security if you do not have the proper credentials to camp.

**The Reserved Parking area East of the Event Center is for the Superintendent, judges, and Show Committee workers only and a Parking Permit is required.**

**Violators will be towed at owner's expense.**

The Show Site will be available to exhibitors at 2:00 pm Wednesday. Dogs must be removed from the show site immediately following Best in Show judging on Sunday.

**Clean up in the ring & on the show grounds is the responsibility of the exhibitor. Ring Stewards will be glad to hold your dog while you clean up. There will be an indoor exercise area inside the Event Center as well as several clean-up stations located throughout the grounds - PLEASE use them.**

Electrical & water outlets on the outside of the Event Center building may NOT be used for any purpose.

**NO PARKING** of any kind will be allowed on the west side of the Event Center, building side - violators will be towed at the owner's expense.

**NO SMOKING WILL BE ALLOWED IN ANY OF THE BUILDINGS - NO VAPOR CIGARETTES ALLOWED.**

There will be **NO** exercise pens allowed in the conformation, obedience or grooming buildings.

No private exercise pens allowed within 10 feet of any entrance.

There will be **no grooming** of dogs in the conformation ring or obedience ring buildings. Short term crating allowed in the conformation ring building 10 minutes before and after ring times and only in the designated areas. Violators will be removed from the building immediately - this will be strictly enforced.

The Show Committee reserves the right to move, arrange or assign grooming setups in both the open and reserved grooming areas.

Please be considerate of fellow exhibitors and do not block the areas designated for loading and unloading. Violators will be towed at the owner's expense.

Dog bathing facility available in the Southwest Motors Event Center locker room - warm water and bath tub available - look for the signs. Facility will be open from 6:00 am until 8:00 pm each day and exhibitors are required to clean up after bathing their dog(s). This area will be monitored at all times and exhibitors will be held responsible for non-compliance. Human bathing facility located in the SW corner of the Carnival lot or in the Horse Show area. Please see show committee member for directions.

No space will be provided for unentered dogs at these shows. No unentered dogs or puppies will be allowed in the building. Failure to comply will result in charges being brought before the Show Committee.

Pursuant to Chapter 10, Section 3 of Rules Applying to Dog Shows, the show veterinarian shall have complete authority to excuse any dogs that have been admitted to the show which he/she considers may endanger the health of other dogs.

SCKC will not tolerate the double handling of any breeds by any person at any time. Any person who attempts to aid or to interfere with any dog in the ring may be subject to action by the Show Committee.

The Show Committee reserves the right to make such other regulations as they may deem necessary (not to conflict with AKC rules) on the day of the show.

The use of foul or abusive language will result in a hearing of the Event Show Committee.

Please obey all NO Parking and Handicapped Parking signs – violators will be towed at owner's expense.

These Fees are paid to the American Kennel Club.

**RETURNED CHECKS / INVALID CREDIT CARDS** do not constitute a valid entry. The Superintendent will add a collection fee of \$25 to the amount of each returned check and credit card. Subsequent returned checks and credit card from the same exhibitors may result in their being put on a cash-only basis.
