

Chapter 11, Section 8, neutered dogs & spayed bitches will be allowed to compete in Veteran Classes.

NON-REGULAR (Additional) CLASSES INVOLVING MULTIPLE DOG ENTRIES (National Only)

Please Note: As the judge's decision in the Stud Dog, Brood Bitch and Brace Classes will be based on the merits of more than one dog or bitch, none of the dogs or bitches making up the entry judged first in the class will be eligible for Best of Breed by virtue of having won these classes.

Stud Dog Class: For Stud Dogs and at least two and not more than four of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog may be entered separately in one of the Regular or Non-Regular Classes or if a Champion of Record, for Best of Breed Competition with the Stud Dog class being an 'Additional Entry' or may be entered for Stud Dog Class only at the Regular entry fee. The Stud Dog unit shall be considered as one entry and requires only one entry fee. The Stud Dog must be entered in the Stud Dog Class and shown in the ring with his Get. Get only will be judged on the merits of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy or the standard of the Breed.

Brood Bitch Class: Same as Stud Dog but substitute Brood Bitch for Stud Dog and Produce for Get.

Generations - For three dogs, regardless of sex, of three successive generations (grandparent, parent, offspring). Entry is made for each dog (three separate entry forms) and there can be no substitutions of dogs. Only one \$30 entry fee is required for the unit of three dogs. Individual dogs may be entered in only one Generations Class unit. Each dog has a separate handler. Champions of Record and altered dogs may be entered.

The Most Versatile Belgian Malinois Award (MVBMA) and Reserve Most Versatile Belgian Malinois Award (RMVBMA) are given to the Belgian Malinois at the National Specialty that excel and qualify in at least three different venues. There is no fee for entry, and membership in the ABMC is not required. However, the dog being entered must be a Belgian Malinois. The Most Versatile Malinois and Reserve Most Versatile Malinois will receive rosettes matching those of the National Specialty's Best Of Breed and Best of Opposite Sex. The award will be presented at the Banquet on May 10, 2025. The winner of the award need not be present to win. If the winner is not present, awards will be mailed at winners expense.

Dogs must earn points in at least three of the five venues to be eligible for the Most Versatile Malinois Award. The five venues are:

- I. Conformation (Saturday May 10th) / Sweepstakes (Friday May 9th)
- II. Herding (points from either Saturday May 3rd C Course OR Monday May 5th A Course Trial I)
- III. Obedience / Rally (Thursday May 8th)
- IV. Tracking (Sunday May 4th)
- V. Agility / Preferred Agility (Tuesday May 6th)

Exhibitors may enter as many venues and classes with a venue as they wish but only the single run that results in the highest number of points within a venue is counted for that venue's points. For example, in the III. Obedience/Rally venue, qualifying in Open in Obedience earns 4 points and qualifying in Master in Rally earns 5 points. The event center will be available to exhibitors Tuesday, May 6, 2025 from 3:00pm - 9:00pm and Wednesday, May 7, 2025 through Saturday, May 10, 2025 from 6:00am - 10:00pm.

All exhibitors are asked to remove all dogs and items from the building immediately upon completion of BOB judging on Saturday, May 10, 2025.

There are NO night time security personnel on site. NO DOGS will be allowed to remain in the building overnight.

- CRATING & GROOMING: Grooming and crating in designated areas only. The bathing of dogs is limited to the bathing area located next to the grooming area. No dogs allowed in bathrooms. NO Ex-Pens allowed inside building at any time. NO CRATES MAY BE PLACED DIRECTLY ON THE FLOORING SURFACE IN THE GREAT HALL. THERE MUST BE PLASTIC OR A RUG UNDER THE CRATE. ALL GROOMING TABLES MUST HAVE RUBBER OR PLASTIC CAPS ON THE END OF THE LEGS OF THE TABLE. No cones are allowed inside building.
- All exhibitors must abide by the 15 minute unloading/loading parking time limit in areas around the Event Center. NO day parking on Level A, B, C or D - RV parking lot. All vehicles must leave their headlights on while unloading. No vehicles may be parked next to the building or in any roadway.

EXHIBITORS & GUESTS

No one is permitted anywhere that is marked "Employees Only" and/or "No Admittance." These are separate divisions of Purina and are not part of the show grounds. No person or dogs are allowed on the second floor of the Purina Event Center. There are no baby strollers allowed inside the building. No firearms allowed on Purina Property. No helium, balloons, glitter, or duct tape allowed inside the facility. Only painter's tape or gaffer's tape may be used.



AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS.

A Recording Fee of 50 cents for each dog and an AKC Event Service Fee of \$3.00 will be required for the first entry and \$3.50 for each additional entry at any Licensed or Member Club Show or Obedience Trial. (American Kennel Club Rule, Chapter 11, Section 2). A \$3.50 AKC Recording Fee will be required for each entry in Rally. (American Kennel Club Rally Regulation, Chapter 1, Section 5). A \$2.00 Event Service Fee will be required for each entry in 4-6 Month Beginner Puppy. \$2.00 Event Service Fee will be required for each entry in FSS Open Shows. These Fees are paid to the American Kennel Club.

RETURNED CHECKS / INVALID CREDIT CARDS do not constitute a valid entry. The Superintendent will add a collection fee of \$25 to the amount of each returned check and credit card. Subsequent returned checks and credit card from the same exhibitors may result in their being put on a cash-only basis.

Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge, or barred from competition by action of the Show Committee.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and or dangerous weather conditions, an Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club or the Superintendent.

No Refund for Duplicate Entries. Every effort to find all duplicate entries will be made; however, if entry has been processed, no refund will be made.

Refunds made for cancellation of entries before the closing date will be subject to a \$3.00 administrative/processing fee per entry.

No Entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.

Judges need not wait for any dog holding up the class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

The show giving club, the Superintendent, their agents, employees, etc., assume no responsibility for any loss, damage, or injury sustained by exhibitors or handlers to any of their dogs or property, and further assume no responsibility for injury to children.

PUBLICATION RIGHTS By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.

- 3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- 3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
