## Non-Regular Classes Involving Single Dog Entries (National Specialty Only)

Unless otherwise noted, winners from the Veteran and Hunting classes are eligible, if undefeated in another class, for Best of Breed competition.

The following non-regular classes will be provided for both dogs and bitches

Entries in the Veteran & Hunting classes need not be intact.

Veteran 7-9 Years Class - 7 Years and Under 9 Years on the day of the show

Veteran 9-11 Years Class - 9 Years and Under 11 Years on the day of the show

Veteran 11 Years & Over Class - 11 Years and Older on the day of the show

Hunting Class - For Dogs and Bitches who have an AKC Hunting title (Junior Hunter,

Senior Hunter or Master Hunter)

## Non-Regular Classes Involving Single Dog Entries (National Specialty Only)

**Altered** (not eligible for Best of Breed) - For Dogs and Bitches who have been altered. These classes will be judged **AFTER** Best of Breed.

## Non-Regular Classes Involving Multiple Dog Entries (National Specialty Only)

**Stud Dog Class** – For Stud Dogs and two or three of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog must be entered in one of the Regular Classes or, if a Champion of Record, in Best of Breed competition, and must be entered in the Stud Dog class as an "Additional Class." The Get must be entered in one of the Regular Classes or, if a Champion of Record, in Best of Breed competition.

The Stud Dog shall be considered one entry and requires one entry fee. The Stud Dog must be shown in the ring with the Get. The class will be judged based on the merits of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the dog show rules, AKC policy, or the standard of the breed.

**Brood Bitch Class** - same as for Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get

\*Chapter 11, Section 8 of the "Rules Applying to Dog Shows" provides that a neutered male may be entered as a Stud Dog in the Stud Dog Class and a spayed Bitch may be entered as a Brood Bitch in the Brood Bitch Class.

**Brace Class** Two dogs of the same Breed or Variety of Breed with one or more common owners and both dogs must be entered in another class.

As the judge's decision in the Stud Dog, Brood Bitch, and Brace classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won either of these classes.

#### \*\*Points Available for Reserve\*\*

The Bracco Italiano Club of America will award at its *National Specialty* a three point major to Reserve Winners Dog if the Regular Class Dog entry is twice the required number for a five point major in the division where the National Specialty is held.

### **National Specialty Sweepstakes**

### **Requirement for Sweepstakes**

The Sweepstakes is open to all Bracchi Italiani who are six months of age and under 18 months of age on the day of the show. All dogs entered in Sweepstakes must also be entered in a Regular Class at the regular entry fee under the same event number. Entries shall be made at the same time, on the same entry form as for Regular Classes. Indicate your "Sweepstakes" Class and age division in the space for "Additional Classes."

### JUNIOR SHOWMANSHIP COMPETITION

Novice Junior 9 & under 12 yrs • Open Junior 9 & under 12 yrs Novice Intermediate 12 & under 15 yrs • Open Intermediate 12 & under 15 yrs Novice Senior 15 & under 18 yrs • Open Senior 15 & under 18 yrs Master Class

Novice Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Show Secretary prior to the judging of the class at the show.

Open Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

Master Class - will be for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Show Secretary prior to the judging of the class at the show.

## AKC NATIONAL OWNER-HANDLED SERIES AT BOTH THE NATIONAL AND PARENT CLUB SPECIALTY SHOWS

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

All dogs that are owner-handled and are not exhibited in the National Owner-Handled Series by professional handlers\* meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers, household members and current assistants to professional handlers may not exhibit the dog in any AKC National Owner-Handled Series competition during the entire show. A current assistant is defined by anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any show during the cluster/weekend, however current assistants that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may participate in NOHS.

Owner-Handled Best of Breed will be selected from the dogs that are competing in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed, or in Best of Winners competition.

\*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.

### **CRUFTS QUALIFICATION**

With the approval of BICA, The Kennel Club (of England) has designated that at the 2023 BICA National Specialty, the following winners will be eligible to enter Crufts 2024 & 2025 (in Birmingham, England) as a U.S. International qualifier. At the BICA 2023 National Specialty, the following awarded exhibits will receive an envelope in the ring with their trophies which includes the certificate to verify qualification. 

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- 5. Mixed Breed dogs entering classes for Agility, Obedience. and Rally trials should mark Breed as AKC Canine Partners Listed Dog "All American Dog/Mixed Breed." Variety, Breeder, Sire, Dam information shall remain blank for mixed breed entrants.
