Chapter 16 Section 1 Rules Applying to Dog Shows

... at the National Specialty the dog designated Reserve Winners Dog and the bitch designated Reserve Winners Bitch will be awarded a three-point major, provided that the number of dogs competing in the regular of the Reserved Winner's sex totals at least twice the number required for a five-point major, in the region in which the event is held.

Herding Titled Classes ▪ Class for dogs & class for bitches over nine (9) months of age that have acquired an AKC Herding Title from Herding Started or higher (Does NOT include Herding Tested, Pre-Trial Tested or Herding Instinct Tests). **Neutered dogs & spayed bitches may compete in Herding Titled Classes. Neutered dogs & spayed bitches may be exhibited in any Non-Regular Single Dog Class entries.**

First through Fourth places will be offered for Herding Titled Classes.

**NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES FOR
BOTH VARIETIES**

Stud Dog Class - For Stud Dogs and at least two and not more than four of their Get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their Get. Owner of the Stud Dog need not necessarily be owner of the Get. Get only to be judged based on the merits of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under Dog Show Rules, AKC policy or the standard of the breed. Get must be entered in a Regular Class, Best of Breed Competition or some other Non-Regular Class.

Brood Bitch Class - Same as Stud Dog except substitute Brood Bitch for Stud Dog and Produce not more than four of their Get.

Brace Class - (Two Dogs of the same variety and must have at least one common owner and presented by a maximum of two handlers) - The dogs comprising a Brace MUST be named at time of entry. If a dog that is to be part of a Brace is not entered in another class, it must be entered for "Brace Class Only." In making entries for "Brace Class Only," full particulars must be given for each dog on individual regular entry forms. An entry form for a dog entered in another class and entered as a part of a Brace MUST be marked accordingly in the space provided for Additional Classes, "Brace Class." If more than one Brace is entered by the same owner, the dogs comprising EACH Brace must be so designated, "Brace No. 1," "Brace No. 2," etc.

As the judge's decision in the Non-Regular Multiple Dog Entry Classes are based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible for Best of Breed/Variety by virtue of having won these classes.

Pee Wee Special Attraction

A Pee Wee Special Attraction will be held Saturday, April 12, at the conclusion of Junior Showmanship judging. Entries accepted April 11 & 12 only (no pre-entries). Entry is Free. Entries limited to no more than 10 children. The entry form and a release must be signed by the child's parent, legal guardian, or a responsible adult.

The Pee Wee Special Attraction is a pre-Junior Showmanship class. The Pee Wee class is geared toward children 5-9 years of age. Children younger than five or older than eight cannot participate in the Pee Wee Class Special Attraction. Each Pee Wee unit consists of the child, his/her parent/ guardian/responsible adult, and the dog. Only one Pee Wee unit is in the ring at a time.

This is not a competitive class, but rather a fun, learning experience for the child and the adult.

- The dog must be at least six months of age.
- Bitches in season will not be allowed to participate.
- All dogs entered must have the proper lead and collar.
- A responsible adult must be present with the child both inside and outside the ring. The adult is to maintain control of the dog outside of the ring.
- The dog must be a Collie.

The safety of both the dogs and Juniors inside and outside the ring is a primary concern. Outside of the ring, the dog is to be controlled by the adult accompanying the child. At the Judge's discretion based upon the size of the child and the dog, for safety purposes the adult may be asked to attach a second lead to the dog so both child and adult will walk the dog together.

To be eligible for this award, a Collie must participate in at least three of the four AKC events offered by the CCA (Breed, Obedience/Rally, Agility or Herding). Sign up for the award at any performance event. You must sign up for the award to be eligible, and signup sheets must be turned in to Beth Elliott by the end of the agility trial. The detailed rules for determining the winner from the Collies that qualify for the award are given below. Note that weighting factors are used in each of the performance events to recognize the increased difficulty of the higher-level classes. In the Non-Best of Variety classes, points are awarded based on the number of dogs defeated in the class. All scores will be recorded from the posted Judge's sheets. Beth Elliott will maintain the official scores at this show. The award presentations will be announced on Saturday, April 12, 2025 in the main conformation ring (Time TBA).

RULES FOR THE MOST VERSATILE COLLIE AWARD

To be eligible for this award, your Collie needs a qualifying score in at least three of the four AKC events at the National Specialty. A Collie that receives MVC points in Breed is considered to have received a qualifying score in that event. Only one score will be counted for each event. The Collie obtaining the highest point total will win the award. The following scoring system will apply:

BREED:

All Collies that are a conformation champion or have at least 5 Championship points will receive a minimum of 40 MVC points for entering and showing in a conformation class at the CCA National.

Collies with less than 5 Championship points will not automatically receive any MVC points for showing in a conformation class. Points will only be awarded for placing in a class and defeating competition.

Since this is an individual award, Brace Class performances do not count.

No points will be awarded to Collies entering a conformation class and not showing (i.e., marked absent).

In the BOV class and Winners competition points will be awarded as follows:

As AKC rules allow, CCA is limiting unentered dog to no more than three dogs per grooming space/booking reservation. (Per reservation - not per grooming space). Dogs under the age of six months are not allowed, the exception being that if the CCA is holding a 4-6 Month Beginner Puppy event, puppies entered in such event may be present. You may be asked for proof of entry. Should this rule be violated by any exhibitor, an event committee hearing will be called.

CANADIAN/FOREIGN exhibitors must make fees payable in U.S. FUNDS. When you provide a check as payment, you authorize us to either use information from your check to make a one-time electronic fund transfer from your account or to process the payment as a check. Please mail checks or money orders with entries. Superintendent assumes no responsibility for cash sent through the mail. Tabulate carefully. Due to cost of processing, no refunds \$4.00 and under will be made.

An AKC Recording Fee of \$.50 first entry only and an AKC Event Service Fee of \$3.00 per entry will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. An AKC Recording Fee of \$3.50 will be required for each first entry and \$3.00 each additional entry in any Licensed or Member Club Rally Trial. An AKC Event Service Fee of \$2.00 per entry will be required for each dog entered at any Open Show. All Recording and Event Service Fees are paid to the American Kennel Club. **(There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes or Special Attractions.) No Entry** shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Event Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner (s) of the grounds and/or facilities or other acts beyond the control of the management, it is impossible to open or to complete the event, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including, but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators.
