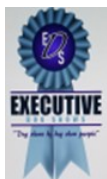

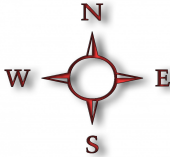

## FOUR-TO-SIX MONTH BEGINNER PUPPY COMPETITION

**Friday, May 24, 2024 ■ Saturday, May 25, 2024**  
**Sunday, May 26, 2024 ■ Monday, 27, 2024**

The Four-to-Six Month Beginner Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will not be divided by sex in this competition. Classes will be offered for Breeds & Varieties and divided into Groups as described in Chapter 3, Section 1 of the *Rules Applying to Dog Shows* and the Miscellaneous Class Breeds as listed in Chapter 3, Section 23. The Miscellaneous Class competition will be equivalent of Group Competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS Competition will be the equivalent of Group Competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the *Rules Applying to Dog Shows*.
- A foreign-born dog may enter this class if they are registered in the country of origin.
- FSS Number of FSS Registered Litter number will be required for Miscellaneous and FSS Breed entries.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Professional handlers are not permitted to exhibit in this class. Dogs that are owned or co-owned by a professional handler may compete in this class but must be handled by a non-professional handler. *Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler.*
- Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur requirements) may personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition.
- Exhibitors should open their dog's mouth for reexamination. If the judge finds it necessary to open the mouth they should disinfect their hands prior to examining other dogs.
- Male puppies without 2 fully descended testicles need not be disqualified or excused but the judge's book must describe the condition and Certificate of merit points may be withheld.
- Dogs with breed standard disqualifications should not be excused but may not receive placements. However, dogs with age related disqualifications such as color (as related to age), height, teeth etc. are permitted to receive awards in the 4-6 Month Beginner Puppy classes.
- Dogs must be excused for attacking a person or other dogs.
- No dog is to be judged if it is brought into the ring bandaged, taped, glued or stitched anywhere including ears and tail. These dogs must be excused from judging but, at the judge's discretion, may return to be judged after the tape or bandage is removed.
- *Dealing with Misconduct* will be applicable to any person and dog entered at the competition. All applicable rules found in *Rules to Dog Shows* will govern the conduct of this competition unless these regulations state otherwise.

**NOVICE JUNIOR CLASS**-For Boys and Girls who are at least 9 years old and under 12 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent prior to the judging of the class at the show.

**NOVICE INTERMEDIATE CLASS**-For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent prior to the judging of the class at the show.

**NOVICE SENIOR CLASS**-For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent prior to the judging of the class at the show.

**OPEN JUNIOR CLASS**-For Boys and Girls who are at least 9 years and under 12 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

**OPEN INTERMEDIATE CLASS**-For Boys and Girls who are at least 12 years and under 15 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

**OPEN SENIOR CLASS**-For Boys and Girls who are at least 15 years and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

**MASTER CLASS**-This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Superintendent named in the premium list to received entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Superintendent prior to the judging of the class at the show.

Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form.

Dogs entered in the Amateur-Owner-Handlers class will be marked as eligible to compete in the NOHS.

Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner.

Professional handlers\*, household members and current assistants\*\* to professional handlers may not exhibit the dog in any NOHS competition during the entire shows. For a detailed description of the National Owner-Handled Series, please visit the AKC NOHS pages at:

## USE OF RAMPS

A judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. AKC approval is not required.

The entire entry in a breed is to be examined in the same manner (ground, table, or ramp).

At the discretion of the judge, the following breeds may be judged on the ground or on a ramp through all levels of competition including Group and Best in Show judging: NS Duck Tolling Retrievers, Spaniels (American Water), Spaniels (Boykin), Spaniels (English Springer), Spaniels (Field), Spaniels (Welsh Springer), Grand Basset Griffon Vendeen, Whippets, German Pinscher, Standard Schnauzers, American Staffordshire Terriers, Irish Terriers, Soft-Coated Wheaten Terriers, Staffordshire Bull Terriers, Finnish Spitz, Entlebucher Mountain Dogs, Finnish Lapphund, Australian Cattle Dog, Icelandic Sheepdogs, Norwegian Buhund, Polish Lowland Sheepdogs, Spanish Water Dogs, and Norrbottenspets (Misc.).

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on the ground, a ramp, or on a table: Miniature Bull Terriers.

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on a ramp, or on a table: Mudi & Puli.

The following breeds must be judged on a ramp through all levels of conformation competition: Lagotti Romagnolo, Spaniels (Clumber), Spaniels (Sussex), Basset Hounds, Cirneco dell'Etna, Kerry Blue Terriers, Bulldogs, Chinese Shar-Pei, Chow Chows, and Keeshonden.

This extends to all conformation competition at AKC conformation dog shows and any AKC event where a conformation title may be earned. This policy includes Group, BIS, Junior Showmanship, the 4–6 Month Beginner Puppy Competition, the AKC National Owner-Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions.

Ramps can be used in emergency situations to judge any breed. In emergency situations where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.

### **Attention Owners/Exhibitors of Foreign Registered Dogs**

If you are the owner/exhibitor of a dog registered with a foreign registry (not yet dual registered with AKC) please review the eligibility requirements in The Rules Applying to Dog Shows, Chapter 11, Section 1.

The dog show rules are posted on the AKC web site at <http://images.akc.org/pdf/rulebooks/RREGS3.pdf>.

Most important to note are the following:

1. Dogs must be individually registered with the American Kennel Club by the day of the event to be eligible for exhibit in the Bred by Exhibitor Class.
2. Dogs are eligible to compete in AKC events using the foreign registration for a period for 30 days. That 30-day period begins with the date of first exhibit, regardless of whether the dog earned any points or awards. To continue to compete in AKC events beyond the initial 30-day period the dog must be either individually AKC registered or by the date of the event have been granted an extension to exhibit using the foreign registration. The owner or agent can request an extension using the form found on the AKC Web site at <http://images.akc.org/pdf/extenap.pdf>.

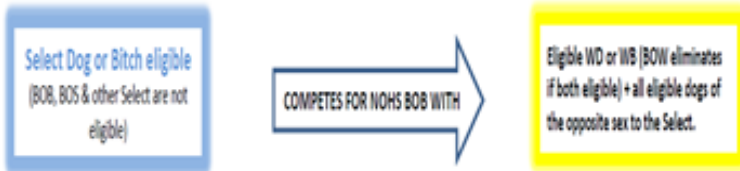
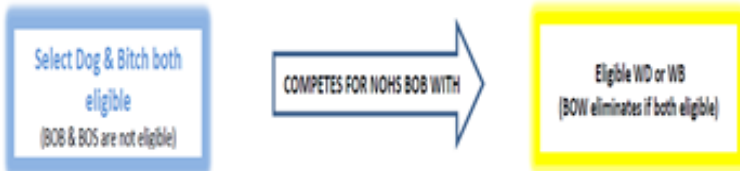
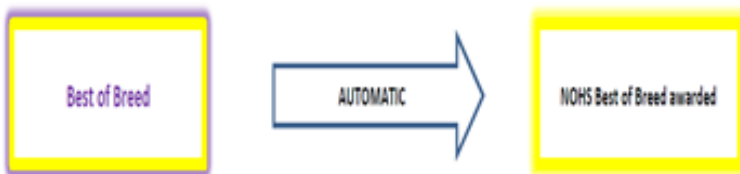

# Designating NOHS Best of Breed



Once the judge has awarded BOB (BOV, BOW, BOS and Selects

- Judge should compare the awards vs. the entries indicated as eligible to compete by an asterisk (\*) in the judges book
- Determine by the flow chart which of entries eligible for NOHS(\*) may have been eliminated by the awards (BOB, BOS, BOW, Selects) and which should remain in the ring for the designation of NOHS Best of Breed



If none of the above awards (BOB, BOS, Select Dog, or Select Bitch) are indicated as eligible, judge is to award NOHS Best of Breed from any eligible dog competing for Best of Breed, including WD and WB. If eligible, BOW eliminates the Winners of the opposite sex automatically.

Dogs must be entered in the NOHS Competition to be eligible for NOHS Best of Breed. (Indicated by an "\*\*")

Only those dogs indicated by an asterisk (\*) and eligible to compete for NOHS BOB (entered in BOB, move-ups, 1<sup>st</sup> place non-regular, WD & WB) are eligible for the NOHS award. Eligible Select DOES NOT automatically eliminate eligible same sex Winners Dog/Bitch.

# AKC Code of Sportsmanship

*PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companionship. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.*

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

**RETURNED CHECKS / INVALID CREDIT CARDS** do not constitute a valid entry. The Superintendent will add a collection fee of \$40 to the amount of each returned check and credit card. Subsequent returned checks and credit card from the same exhibitors may result in their being put on a cash-only basis. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. **I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN ITS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.**

**INSTRUCTIONS**

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed.

4. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)

5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as AKC Canine Partners Listed Dog "All American Dog/Mixed Breed." Variety, Breeder, Sire, Dam information shall remain blank for mixed breed entrants.
