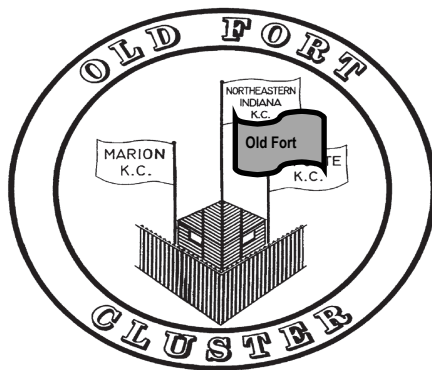

10. Supervised Separation (3 minutes owner out of sight)
