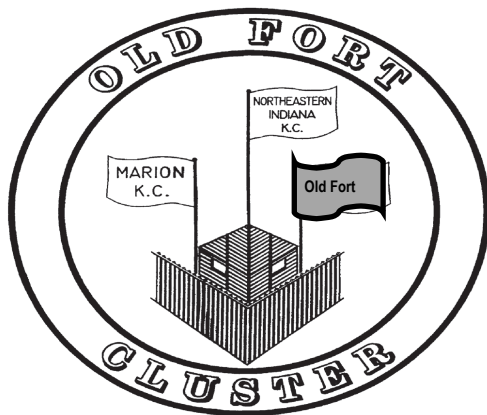

10. Supervised Separation (3 minutes owner out of sight)

5 Trick Dog Titles:

- **Novice Trick Dog (TKN)** The dog performs 10 skills from the Novice list. (see line to "Application" below for list of skills). If a dog has a Canine Good Citizen (CGC) certificate or title on record at AKC, it can do 5 Novice tricks (CGC + 5) to earn the Novice title.
