### Direction to the Events

**I-71 from the North** –Go South on I-71 to Exit #32 (Morrow/Lebanon Rt. 123). West on Rt. 123 to Rt. 63. Follow Rt. 63 West until dead-ends into Rt. 4. Take Rt. 4 South to Hamilton, show site on left.

**I-75 from North or South** –Exit #24 (Rt. 129). West on Rt. 129 until the freeway ends at Fair Ave. Turn right on Fair Ave. for about 1/2 mile. Fairgrounds entrance on right.

**I-71 from South** - Combines with I-75 South of Cincinnati. Go North into Ohio to Exit # 24 (Rt. 129). Then follow I-75 North or South directions.

**I-74 from the West** - Take the I-275 to I-75. Then follow I-75 North or South directions.

**I-74 from the East** –Take I-275 North to I-75. Then follow I-75 North or South directions.

**HANDLER:** The handler of a Sweepstakes exhibit must be either the owner, co-owner, breeder or member of their immediate family as they are listed on file with the American Kennel Club as of the closing date for the show for which the sweepstakes entry is being made. Immediate family is defined as husband, wife, mother, father, brother, sister, son, daughter, or legal domestic partner. Step children and legal wards are also included in this definition. In-laws and grandchildren are not considered to be immediate family members. No other individual may take the entry into the ring during judging or check-in.

The following individuals are excluded from showing an exhibit in sweepstakes unless they are the sole owner registered with AKC or co-own the entry with a member of their immediate family (as defined above) or a legal domestic Partner.

Any individual listed as an agent on any dog in any regular or non-regular class at this or any other show in the previous two years. Any individual with an Agent number including, but not limited to an AKC Registered Handler Number or Professional Handlers Association (PHA) number.

Dogs are not required to be at the show until schedule time of judging. All dogs not needed for further judging will be excused.
