

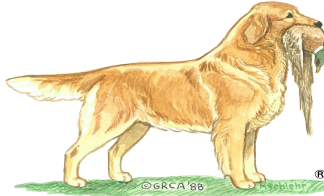

BEST OF BREED COMPETITION

AWARD OF MERIT

The Best of Breed Judge may award a JAM up to 10% of the Specials entry to dogs which are especially meritorious. A Dark Green Rosette will be given.

NON-REGULAR CLASSES INVOLVING SINGLE DOG ENTRIES

VETERAN CLASSES* : Any purebred Golden Retriever over eight years of age which is individually registered with the AKC. Entrants need not be entered in any other class. AKC Champions of Record and spayed or neutered Golden Retrievers are eligible. *Chapter 11, Section 8 "Rules Applying to Dog Shows" provide that a neutered male or spayed bitch may be entered as a veteran. Winners of the above classes are eligible to compete in the Best of Breed Competition.

HUNTING RETRIEVER CLASS: For any dog or bitch that has earned a Senior or Master Hunter title under AKC rules. Please be aware that the Upland Hunting Test titles do not qualify a dog for this event.

FIELD TRIAL CLASS: For any dog or bitch that has won, placed or received a Judge's Award of Merit in any AKC licensed or member field trial. *Chapter 11, Section 8 of the "Rules Applying to Dog Shows" provides that a neutered male may be entered as a Veteran Dog in the Veteran Dog Class and a spayed bitch may be entered as a Veteran Bitch in the Veteran Bitch Class.



SWEEPSTAKES AND VETERAN SWEEPSTAKES Handler Requirements:

The handler of a Sweepstakes exhibit must be either the owner, co-owner, breeder or member of their immediate family as they are listed on file with the American Kennel Club as of the closing date for the show for which the sweepstakes entry is being made. Immediate family is defined as husband, wife, mother, father, brother, sister, son, daughter, or legal domestic partner. Step children and legal wards are also included in this definition. In-laws and grandchildren are not considered to be immediate family members. No other individual may take the entry into the ring during judging or check-in.

The following individuals are excluded from showing an exhibit in sweepstakes unless they are the sole owner registered with AKC or co-own the entry with a member of their immediate family (as defined above) or a legal domestic partner.

Any individual listed as an agent on any dog in any regular or non-regular class at this or any other show in the previous two years. Any individual with an Agent number including, but not limited to an AKC Registered Handler Number or Professional Handlers Association (PHA) number.

The Gun Dog Sweepstakes is open to any purebred Golden Retriever which is individually registered with the AKC. Entrants **NEED NOT BE** entered in a Regular Class. AKC Champions of Record and Spayed or neutered Golden Retrievers **ARE** eligible. Handlers will not be required to be an owner. Entry in the Gun Dog Sweepstakes must be made by indicating in the box for "Additional Classes" your entry into the Veteran Sweepstakes and age division.

ELIGIBILITY: Any purebred Golden Retriever with and AKC Hunting Title, ** or *** designation earned in an AKC Retriever Field Trial. AKC and CKC Champions of Record spayed and/or neutered dogs are eligible for this competition.

BEST JUNIOR SHOWMANSHIP

NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent named in the premium list to received entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent prior to the judging of the class at the show.

NOTICE: Junior Handlers must include their AKC Junior Handlers Number on each entry.

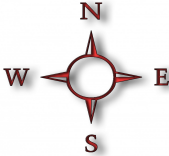

AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companionship. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
