DCA HOTEL POLICY: Any exhibitor who allows his/her dogs to be loose & unattended in a room or to damage hotel property & does not immediately contact the hotel management to make proper restitution will be subject to a Show Event Committee action which could result in the loss of AKC privileges. If it is determined by the Committee hearing that rules are being neglected & destruction and/or misuse of property is taking place, the Committee has the authority to correct the problem or seek AKC suspension.

ONLY DOGS THAT ARE ELIGIBLE to be shown under the **American Kennel Club Rules** shall be allowed within the Show Precincts. PUPPIES UNDER FOUR (4) MONTHS ARE NOT ALLOWED on the Show Precincts or at any events associated with or held in conjunction with the DCA Specialty Show. The Show Event Committee has the authority to correct a violation of this AKC Rule.

RV PARKING

RV Parking is managed by the GNFA. Advance reservations are required. Make reservations through the GNFA website at <https://sitereservations.com/> Daily rental rates are \$45 for 30 AMP or \$55 for 50 AMP. All sites come with water and sewer or a free honey wagon service provided through the fairgrounds. NOTE: You do not get to pick your location with regular RV parking.

Upgraded PREMIUM RV sites are available, choose your exact location close to all the action for a one time up charge plus the daily rental fee from the fairgrounds. Your spot will be marked with your name or kennel name on an adorable garden flag with the DCA 2024 National logo or performance logo. A one time up charge of \$30 or \$75 plus the daily rental rate to the fairgrounds is required. Upgrade your reservations through the DCA online store for Upgraded Premium RV sites at <https://dalmatianclubofamerica.org/product-category/2024-national-specialty/2024-national-specialty-rv-camping-and-preferred-parking-packages/>. And for \$50 more, you will also have reserved grooming/crating in the Miller Murphy Howard building!

ONLY those with a **RESERVED PARKING PASS** will be allowed to park near the Murphy Miller Howard Building.

Designated Parking is outside the main gate. **DO NOT** park in spaces reserved for judges or workers

DO NOT park in an RV site and **DO NOT** block an RV site.

ATTENTION EXHIBITORS

- * All dogs must be kept on leash except when actually competing in the Agility, Barn Hunt, Fast CATs, Obedience, Rally, Road Trial, Scent Work rings or fields.
- * The show site will be made available to exhibitors, Thursday June 13, 2024
- * **The reserved grooming building will be made available Sunday, June 16, 2024 in the Miller Murphy Howard Building after 4 PM. There will be an area for free grooming available each day and DCA reserves the right to require that all crating must be stacked. There will be no ringside crating. Dogs may be crated in the area from 6 AM until the conclusion of the evening events on June 16, 2024 through June 22nd, 2024. DOGS MAY NOT BE LEFT OVERNIGHT IN THE BUILDING.**
- * No unentered dogs or puppies allowed in building per AKC guidelines.
- * No working (practice) in rings before or after show hours. Dogs are allowed in rings only during judging hours and scheduled practice times.
- * No dogs allowed in restrooms and no washing of animal food containers in restrooms. Bathing of dogs limited to bathing area.
- * Pick up after your dogs and dispose in provided receptacles.
- * **No videotaping or photography during the events for resale is permitted without the Dalmatian Club of America, Inc. approval.**
- * **Please be advised:** when an exhibitor/handler brings a dog to the podium for a win/placement photo they are establishing a de facto contract with the show photographer to purchase that photo.
- * **No baby strollers are allowed in the show site or adjacent hallways during show hours.**
- * Unless otherwise specified, all trophies must be claimed the day of the show. **None will be mailed.** The club reserves the right to substitute a prize of equal or greater value.
- * **Waiver of Rights The club reserves the right to remove any animal in distress from a parked vehicle or crate, and all persons attending these dog events hereby waive any claim for damages against the clubs for such removal. PLEASE NOTE: It is expressly understood that exhibitors or spectators alone are responsible for the behavior of their dogs and/or children. Any exhibitor or spectator whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior or whose equipment creates an impediment to the safe flow of traffic may, at the discretion of the Event Committee, be asked to leave the event site. NOTICE TO EXHIBITORS - ALL EVENTS



The American Kennel Club Rules and Regulations will govern this show and exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List.

The American Kennel Club will collect: a \$3.00 Event Service Fee for the first entry of a dog and \$3.50 service fee for each additional entry of the same dog in the regular and non-regular recordable single-entry classes, in all AKC licensed and member club events. (There is no recording fee or event service fee for sweepstakes, futurities, brace/team, multi-dog classes or special attractions.) The current 50 cent recording will continue to be collected. The event-giving club shall assume the responsibility of collecting all Event Service Fees for the American Kennel Club.

- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. The Club and/or Executive Dog Shows, LLC assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. RESPONSIBILITY FOR COMPLETENESS OF ENTRY RESTS SOLELY WITH ENTRANT.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. Executive Dog Shows will add a \$30.00 collection fee to the amount of each returned check. We will not re-process checks. The exhibitor will be contacted & required to send a money order for the original amount PLUS the \$30.00 NSF fee. Subsequent returned checks from same person may result in their being put on a CASH ONLY BASIS.

Points for Reserve- DCA will award at its National Specialty a three point major to Reserve Winners Dog/ Bitch if the Regular Class Dog/Bitch entry is twice the required number for a five point major in the division where the National Specialty is held.

Non-Regular Classes (Involving multiple dog entries)

Note: Non-regular classes involving multiple entries may be judged before or after Best of Breed. As the judge's decision in these classes will be based on the merits of more than one dog, no one of the dogs making up the entry judged first in the class will be eligible to compete for Best of Breed or Best of Opposite Sex to Best of Breed by virtue of having won the class.

Stud Dog Class and Brood Bitch Class (National): Each entry is allowed two get/produce. The merits of the Stud Dog or Brood Bitch are not considered in the placement of the entry. It is the quality of the get/produce that forms the basis for the judge's decision. All get/produce must be examined and gaited. The Stud Dog or Brood Bitch must also be examined to determine if there is a condition that would require disqualification or excusal under the Rules, AKC policy or breed standard. All get/produce must be entered in another class in order to be eligible to compete in the Stud Dog or Brood Bitch Class. Handlers of the Stud Dog or Brood Bitch, and all get/produce being exhibited, must bear armbands. Ch 11, Sec. 8 of the "Rules Applying to Dog Shows" provides that "Neutered dogs may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class."

CLASSIFICATIONS

Brace Class (National Only): Two Dogs, performing in unison, and presented by a maximum of two handlers. Both dogs competing in the brace class must have at least one common owner. Both dogs do not need to be entered in any other class. Dogs comprising a Brace Class must be named at the time of entry, and full particulars must be given for each dog on individual entry forms. An entry form for a dog entered in another class and entered as part of a Brace must be marked accordingly in the space provided for additional classes as "Brace Class." If more, than one brace is entered by the same owner, it must be so designated "Brace #1", "Brace #2", etc.



FOR THESE CONFORMATION EVENTS SCHEDULED JUNE 17th-20th, THE AGE OF THE DOG ON JUNE 18TH DETERMINES THE APPROPRIATE AGE-RELATED CLASS. THIS APPLIES TO SWEEPSTAKES, FUTURITY, REGULAR CLASSES AND VETERAN CLASSES AT THE NATIONAL SPECIALTY ONLY.

JUNIOR SHOWMANSHIP COMPETITION

NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

NOVICE AND OPEN CLASS DIVIDED: Junior - 9 years old and under 12 years old on the day of the show; Intermediate - 12 years old and under 15 years old on the day of the show; Senior - 15 years old and under 18 years old on the day of the show.

After the judge has awarded the Best Junior Handler, the second place winner from the class that the Junior was awarded Best Junior Handler is to return to the ring to compete for Reserve Best Jr. Handler.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, 919-233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being substituted is not otherwise entered in the show, the Junior Showmanship Only fee applies.

AKC NATIONAL OWNER-HANDLED SERIES

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form. Dogs entered in the Amateur-Owner-Handler class will automatically be marked as eligible to compete in the NOHS.

Eligible dogs will be identified by an asterisk in the judge's book, steward's book and the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers*, household member and current assistant** to professional handlers may not exhibit the dog in any NOHS competition during the entire show. **Professional handlers are defined as any person who belongs or has belonged to a professional handler's organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.

Dogs shown in Futurity must also be entered in one of the regular classes at the regular entry fee and on the regular entry form. Entrants may be shown by owners or agents. Indicate your Futurity Class with the age division in the space provided for "Additional Class." The Dalmatian Club of America, Inc. (DCA) Futurity is open to dogs & bitches that are from properly nominated litters pursuant to DCA Futurity Rules & to dogs & bitches that have been properly nominated prior to four months of age. The breeder of the dog or bitch must be a member in good standing of the DCA. The name & AKC registration number of each entry, as well as the owner's name & address, must have been conveyed to the Futurity Chairman at least one month prior to the date of the Futurity.

Division of Fees as Prizes

The fee to enter a puppy in Futurity shall be a total of \$42, \$10 of which shall be considered the sustaining fee and the remaining \$32 is the actual entry fee to enter the class and will be retained by the superintendent/secretary and the Club for show expenses. The Futurity purse is the total of all nomination fees and sustaining fees minus the 20% that is deducted from the total purse to be used for Futurity expenses.

20% of the total nomination and sustaining fee purse will be retained by the Club for Futurity expenses.

60% of the total purse will be divided according to the percentage of the total entry represented by the number of dogs in each class.

The division of monies in each class will be:

First.....40% of the Class Purse

Second...30% of the Class Purse

Third.....20% of the Class Purse

Fourth.... 10% of the Class Purse

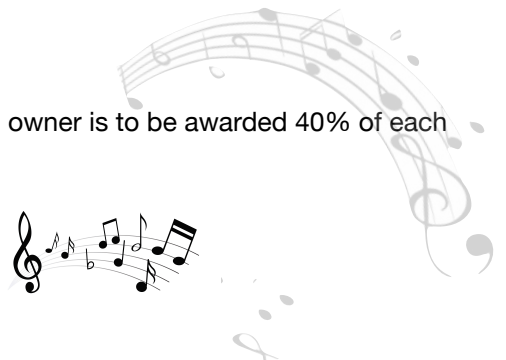
All of which the recorded breeder is to be awarded 60% and the recorded owner is to be awarded 40% of each individual monetary award in each class.

20% of the total purse will be awarded as follows:

Best in Futurity 50%

Best Junior in Futurity 25%

Best Senior in Futurity25%



The 50% Best in Futurity Award will be divided 50% to the recorded breeder and 50% to the recorded owner. The 25% Best Senior in Futurity and Best Junior in Futurity Awards will be divided 50% to the recorded breeder, 30% to the recorded owner, and 20% to the owner of the sire or owner of the frozen semen at the time of mating for each

winner. Notwithstanding the foregoing, all awards will be made to the winner in strict accordance with the Futurity rules. Payment of all Futurity monetary awards will be made to the winner by the DCA Futurity Chair, subsequent to his/her certification of winners.

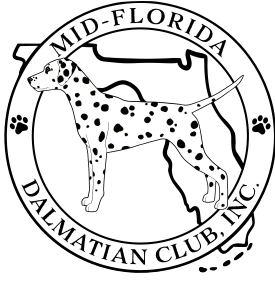
