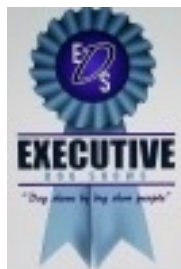

All RV/Campers staying overnight at the Sussex Fairgrounds must make reservations and park in their assigned spaces. The parking area will be restricted to RVs, campers, guests and their dogs only. Parking will be available from Saturday, June 5, 2021 through Friday, June 11, 2021. Most parking areas will be on gravel or grass. Some are on paved roads. Electric is available at all sites, water at most, though can be shared between spaces. There is a dump station at the Fairgrounds, but not at each camp site. Specifics as to fees and directions for dumping will be included in later communications.

Spaces will be assigned according to size, space availability and the order in which reservation forms are received. If campers wish to park together, please indicate that on your form. We will do everything we can do to accommodate your request; however, we can make no guarantees. If you plan to use a generator, please use an exhaust system with an extension to reduce fumes.

Parking reservations must be received by May 12, 2021. The parking fee charged by the Fairgrounds is \$50.00 per night.

RV parking funds refunds will not be made after the close of entries. Additional information regarding RV parking will be shared via the 2021 BTCA Specialty website as it becomes available.

## BORDER TERRIER CLUB OF AMERICA, INC. ROOM RESPONSIBILITY POLICY

The Border Terrier Club of America, Inc. has adopted the following rules in order to ensure that its members and their dogs will be welcome at hotels in the future. Any individual attending a BTCA sanctioned event and staying in a hotel, motel, inn, or on a campsite/fairground has the responsibility of leaving that room or campsite exactly as found. This includes picking up after dog (s) on the grounds. Anyone who damages a room or campsite/fairground and does not report the damage to the hotel/motel/campsite/ fairground management and make immediate restitution or arrangements to do so within a period of time agreed upon by the management, will be subject to any or all of the following actions by the BTCA Board of Directors:

1. May be banned from showing at the next BTCA sanctioned events
- (s). 2. May be subject to AKC sanctions.
3. Membership in the BTCA may be terminated and may not be allowed to be reinstated. **Damages shall be defined as:**
  1. Flea infestation, urine, defecation and/or any damage to hotel/motel/campsite/ fairground property (walls, bedspreads, carpets, drapes, etc.)
  2. Any verified complaint by the host/hotel/campsite/fairground.
  3. Any verified complaint by a BTCA member.

### **BTCA Room Regulations :**

1. All dogs shall be crated and quiet when left alone in a room. Noisy dogs shall be quieted upon request, even if this means the owner/handler must stay in the room with the dog.
2. Individuals will be expected to immediately report any damage by dogs or themselves to the hotel/campsite/fairground management and to assume complete financial responsibility for those damages.
3. No bathing or grooming of dogs will be allowed in rooms. A grooming room will be available whenever possible.
4. Dogs are allowed to be on hotel furniture/beds ONLY if the furniture is covered with protective covering provided by the owner/handler.
5. All owner/handlers will take preventative measures to assure that their dogs are free of fleas, mites, intestinal parasites, and other communicable diseases prior to arriving at the hotel/campsite.

### **SHOW VIDEOGRAPHY**

Events to be filmed: All regular and non - regular conformation classes, Puppy and Veteran Sweepstakes, Junior Showmanship. This show may be video recorded for judges use or educational purposes.. No commercial video recording, video recording from a tripod or monopod mounted camera, or any video recording or streaming of large segments of the show will be permitted. Submission of an entry form and/or physical presence on the show grounds shall constitute both implied and real consent for both the handler and their dog to be video recorded. Online streaming of show video to Facebook, YouTube, FaceTime, U - Stream, Live Stream, or other comparable online outlets is strictly forbidden! Violation of these show video policies may result in an Event or Bench Committee hearing.

All rights to TELEVISION, VIDEOTAPE, ADVERTISE, PHOTOGRAPH, PROMOTE or otherwise exploit these events are vested in the BTCA or in persons to whom assignments of such rights have been made in writing by the BTCA. All persons and animals on the show grounds at any time while the events are in progress do, by attending these events or participating therein, grant to the BTCA the right to photograph, televise, videotape, audiotape, or otherwise use their likeness and voice in any manner without further release or consent. The BTCA is not responsible for the actions or products of the commercial vendors at these events.

### **EXHIBITOR GUIDELINES**

**RINGSIDE:** Dogs may arrive at any time prior to their scheduled time of judging. Judges will not wait for any dog. Owners and agents alone are responsible for the presence of their dogs at ringside when their class is called. The club, judges, stewards, and superintendent have no obligation or responsibility to announce for, or locate dogs that are not ringside when required.

**LIABILITY:** It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such cases, no refund of any fees paid will be made. The club, hotel, superintendent, and any of their agents or employees will assume no responsibility for any loss, damage, or injury sustained by exhibitors or handlers, or to any of their dogs or property, and further assume no responsibility for injury to children. Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Dogs found in an unsafe environment, distress, or harm's way (for example left unattended on a grooming table in a noose not attached to a safety release clip; left in a vehicle without proper ventilation) will be removed to safety. Exposing a dog to an unsafe environment, distress, or harm's



way is considered mistreatment. All persons attending this show hereby waive any claim for damages against the host clubs in the event a motor vehicle has to be entered to rescue a dog from overheating or improperly vented conditions.

**Note: Flexi leashes are prohibited on show grounds**

- RV and trailer reservations will begin Saturday June 5, 2021. Designated grooming areas will be available from Sunday June 6, 2021 after 6:30 PM. The site will then be available from 6:00 AM to 10:00 PM Monday through Thursday.

- NO DOUBLE HANDLING will be permitted at these shows. Individuals who attempt to double handle from outside the ring will be subject to action by the Show Committee.

- There shall be no drilling nor intensive or abusive training of dogs on the show grounds

- The club reserves the right to remove any animal in distress from a parked vehicle or crate in any way necessary. The club solely determines if said animal is in distress. All

persons attending this dog show hereby waive any claim for damages against the host clubs in the event a motor vehicle has to be entered to rescue a dog from overheating or improperly vented conditions.

- **Exhibitors are required to clean up after the dogs they are exhibiting, or which are under their care or control. This requirement includes both while in the ring or at any location on the show site. Clean-up tools and supplies will be available at each ring and at other convenient locations.**

- Final clean-up of the grooming area will be the responsibility of each owner. Clean-up tools and supplies will be available at each ring and at other convenient locations.

- Crates must be stacked whenever possible.

- Dogs are not permitted in the rest rooms, showers, or food areas.

- Parking in loading/unloading areas is prohibited.

- No unsupervised dogs in outside ex - pens between 10:00 p.m. and 6:30 a.m. At all times, be considerate of your fellow exhibitors.

## **COVID-19 Operating Guidelines**

The Border Terrier Club of America organizers will comply with AKC, state and local government and public health authorities to determine Covid risks and mitigation factors. At this time, these are the advised guidelines. These guidelines may be revised as circumstances dictate.

### **On Site Process and Procedures**

Border Terrier Club of America, Inc. shall require temperature monitoring for volunteers, officials, exhibitors, and service providers once daily prior to entering the event areas. Anyone with a temperature of 100.4 or higher will not be allowed to enter the event areas.

Everyone entering showgrounds will be required to wear a mask. Signage to this effect will be posted at the entrance and throughout the grounds.

The following individuals will not be permitted on the showgrounds:

- An individual who exhibits COVID-19 symptoms

- An individual who has tested positive for COVID-19 within last two weeks
- An individual who has been in contact with someone who has tested positive for COVID-19 within the last two weeks

All Specialty participants will be required to sign a Border Terrier Club of America INC. Health Acknowledgement & Liability Waiver in order to remain at our scheduled events.

NOTE: As the judges' decision in the Non - Regular Classes Involving Multiple Dog Entries is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in this class will be eligible to compete for Best of Breed by virtue of having won this class. Chapter 11, Section 8 of the Dog Show Rules provides that a "castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class."

**STUD DOG CLASS:** For Stud Dogs and TWO of their Get. The Stud Dog must be entered in the Stud Dog Class and must be shown in the ring with its Get. Get MUST be entered in another Class. The owner of the Stud Dog need not necessarily be the owner of the Get. Only the Get is to be judged based on their merits, while the merits of the Stud Dog are not to be considered in the placement of the entry. Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show rules, AKC policy, or the Standard for its breed.

**BROOD BITCH CLASS:** Same as for the Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get.

**BRACE CLASS:** Two dogs of the same breed and must have at least one common owner and presented by a maximum of two handlers. The dogs comprising a brace must be named at time of entry. Dogs must also be entered in a regular or non - regular conformation class. Champions of Record and altered dogs may be entered. "Brace" must be marked accordingly in the space provided for Additional Classes, "Brace Class." If more than one Brace is entered by the same owner, the dogs comprising EACH Brace must be so designated "Brace No 1," "Brace No 2." and so forth.

**TEAM CLASS:** Same as Brace, except substitute Team for Brace and four dogs and handlers for two  
**BREEDERS CLASS:** The Breeders Class is a multiple entry class consisting of 3-5 dogs regardless of sex. This class is open to all breeders. All dogs entered must have at least one breeder in common who must be present. The individual dogs comprising the entry must be from at least two different combinations of parent but need not be owned or handled by the breeder. Entrants must be entered individually in some other conformation class. Each dog must be entered on a separate entry form and all forms submitted together. ## **BEST BRED BY EXHIBITOR, BEST VETERAN, BEST WORKING**

First place in each Bred By Exhibitor class will compete for Best Bred By Exhibitor. If the BBE class winner is Best of Breed or Best of Winners, that BBE dog/bitch will automatically win Best Bred By Exhibitor. First place in each Veteran class will first compete for Best Veteran. If a Veteran wins Best of Breed, it will automatically win Best Veteran. Winners of the Working Dog and Working Bitch classes compete for Best Working. If a Working winner wins Best of Breed, it automatically wins Best Working.

## **BEST OTTER HEAD**

Best Otter Head is open to all conformation and performance entries at the Specialty. The judge will select that entry whose head best fits the breed standard. There is no entry fee for this competition. It is not necessary to sign up for Best Otter Head as a separate class.

**Master Class** - will be for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year. No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries,

prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

## **Border Terrier Club of America COVID-19 Operating Guidelines**

The Border Terrier Club of America organizers will comply with AKC, state and local government and public health authorities to determine Covid risks and mitigation factors. At this time, these are the advised guidelines. These guidelines may be revised as circumstances dictate.

### **On Site Process and Procedures**

Border Terrier Club of America, Inc. shall require temperature monitoring for volunteers, officials, exhibitors, and service providers once daily prior to entering the event areas. Anyone with a temperature of 100.4 or higher will not be allowed to enter the event areas. Everyone entering showgrounds will be required to wear a mask. Signage to this effect will be posted at the entrance and throughout the grounds.

The following individuals will not be permitted on the show grounds:

- An individual who exhibits COVID-19 symptoms
- An individual who has tested positive for COVID-19 within last two weeks
- An individual who has been in contact with someone who has tested positive for COVID-19 within the last two weeks.

### **Signage**

The Border Terrier Club of America, Inc. will post signage that displays all applicable federal, state and local regulations, requirements and orders as well as WHO recommendations and CDC guidelines as they relate to mass gatherings and sporting events in effect at the show.

Signage will be posted at all entrances to the show grounds which identifies the symptoms of COVID-19 and states the following:

- To protect others from possible transmission of the virus, anyone who exhibits COVID-19 symptoms or has been in contact with someone who



has tested positive for COVID-19 within the last two weeks (exception, healthcare personnel who have treated patients using appropriate medical-grade PPE during the course of performing professional duties), can not enter the show grounds. These individuals are encouraged to contact their health care provider immediately for further medical advice and must obtain documented clearance from their health care provider before entering the show grounds. Participants must assume responsibility for themselves and their own staff (e.g. assistants, etc.).

- Recommendations about good hygiene along with informing participants and others about ways to reduce the risk of COVID-19 transmission.

### **Social distancing and limiting entries**

- The Border Terrier Club of America, Inc. shall enforce social distancing requirements throughout the showgrounds at all times.
- Prohibit the public and non-essential personnel from being on the show grounds. Non-participants may watch from outside the tent with proper distance between spectators but will not be allowed inside the tent.
- Organize dog and exhibitor arrivals and departures to limit contact between people, exhibitors must leave the tent immediately after showing and cannot return unless they have another dog to show or need to return to the ring with their dog.
- Arrange judges' and other officials' areas to comply with social distancing requirements.
- Restrict show officials and judges' areas access to essential personnel only. Limited entry will be considered if necessary. Regardless of the scope of the limitation, the limiting of entries must be done on a first come, first served basis and relevant information will be posted on the Show secretary's Website.

### **Enforcement Authority:**

Stewards, Club Officials and AKC officials will inform individuals when they are not in compliance with the regulations and requirements in effect at the show and shall report such situations to the Club Officials and AKC. The Border Terrier Club of America has the authority to remove from the facility any person who does not comply with the regulations and requirements in effect.

If an individual needs an accommodation under the American Disabilities Act, a request should be submitted, along with documentation of the disability and need for accommodation, to Nina Fetter, Executive Dog Shows. Requests for accommodations will be reviewed on a confidential basis with a medical consultant. Participants are required to comply with these and any additional Show Organizer requirements at all times while present on show grounds. Failure to do so may result in expulsion from the grounds. These requirements are in effect immediately and until further notice, however, they are subject to revisions as the COVID-19 environment changes.

### **Recommended Best Practices Covid-19**

The following Recommended Best Practices have been provided to assist Show Organizers with determining risks and developing measures to mitigate those risks:

- Limit the number of entrances and exits to event areas to manage the

- number of individuals accessing event areas.
- Communication - Use radio, cell phone communication methods as much as possible and communicate important information frequently throughout the show grounds.

### **Ring Procedure**

- All dogs enter on one side of the ring and exit on the other side
- Dogs will stand in the designated line, when the judge is examining the dog, the exhibitor and dog will move up to the next line and do their individual movement and return to the end of the line. The judge will point to the dog for its placement while standing in the lines (spaced 6 feet away from the other dogs).
- Provide markers to delineate 6 feet spacing between people in any waiting lines.

### **Armbands Procedure**

- There will be tables set up by class to pick up armbands. Please allow for extra time to get your armband.
- There will be no gathering around the tables.

### **Parking Considerations**

- Parking areas will be maintained separate from event areas. RV parking is separate from regular auto parking.
- RV's will all be parked facing the same direction to ensure maximum separation of RV entrance/exits.
- Automobiles will be parked in a separate area and will be parked no less than 6 feet apart.

### **Considerations for Club Members, Medical Personnel, Service Providers & Volunteers**

- Cleaning/Sanitizing Locations will be provided with access to soap and water or alcohol-based hand sanitizer at several areas through the grounds.
- Hand sanitizer will be provided to all officials, ring crew, clean up and medical officials.
- There will be frequent cleaning and sanitizing of bathrooms. Soap and water or alcohol-based hand sanitizer will be provided in bathrooms.
